1. Find the limit as $t \to +\infty$ of the formal solution to the following initial/boundary value problem for the heat equation:

$$\frac{\partial u}{\partial t}(x,t) = \frac{\partial^2 u}{\partial x^2}(x,t), \ 0 < x < \pi, \ t > 0;$$
$$\frac{\partial u}{\partial x}(0,t) = \frac{\partial u}{\partial x}(\pi,t) = 0, \ t > 0;$$
$$u(x,0) = \begin{cases} 1, & 0 < x < \pi/2, \\ 0, & \pi/2 \le x < \pi. \end{cases}$$

(You can take the $t \to \infty$ limit inside series without providing justification.)

Let
$$f(x) = \begin{cases} 1, 0 < x < \frac{7}{2} \end{cases}$$
; decompose it into Fourier series: $(x, x) = \frac{2}{2} + \sum_{k=1}^{\infty} a_k \cos(kx)$. The solution to the heat equation is $u(x,t) = \frac{2a}{2} + \sum_{k=1}^{\infty} a_k e^{-tk} \cos(kx)$.

As $t \to +\infty$, each term $a_k e^{-tk} \cos(kx)$ converges

No justification is required. For each of the questions (a), you get 2 points if you answer it correctly, -1 point if you answer incorrectly, and 0 points if you decide not to answer. For each of the questions (b), you get 1 point if you answer it correctly, -1 point if you answer it incorrectly, and 0 points if you decide not to answer. If your total score for this problem is negative, it will be replaced by zero.
